



# WSG Energy Group: "The EU Third Energy Package: Where Are We Now?"



It has been approximately two years since the EU Third Energy Package entered into force. The transposition date for certain provisions has now passed, though in many Member States implementation has proceeded slowly. With the transposition date for transmission unbundling coming up in March 2012, we look at how each Member State is approaching implementation, as well as how the network operators are reacting to their new obligations and consider what work is currently being undertaken in advance of applications for certification.
