Summary: Classifies the "Pedra Laúca", situated in the Commune of São Pedro da Kilemba (Nhang- -ya-Pepe), Municipality of Kambambe, Province of Kwanza-Norte, as National Historical-Cultural Heritage.

#### PRESIDENTIAL DECREE NO. 174/15 - PRESIDENT OF THE REPUBLIC

# PRESIDENTIAL DECREE NO. 173/15 - PRESIDENT OF THE REPUBLIC

#### DIÁRIO DA REPÚBLICA SERIES I NO. 128, 15 SEPTEMBER 2015

**Summary:** Gives a pardon to people condemned to prison sentence not exceeding 12 years and to correctional sentences, who have served half of the sentence until 17 September 2015. Gives a pardon to condemned women responsible for the care of children under the age of 12 years, provided that death has not resulted from the crime committed. Commutes, up to ¼, the prison sentences exceeding 12 years, when half of the sentence has been served until 17 September 2015.

# PRESIDENTIAL DECREE NO. 180/15 - PRESIDENT OF THE REPUBLIC

#### DIÁRIO DA REPÚBLICA SERIES I NO. 133, OF 29 SEPTEMBER 2015

Summary: Commutes the prison sentence imposed to the defendant Sacafunco Cambucue on half of the sentence.

**Summary:** Sets up the ad hoc group responsible for accompanying the processes and procedures of private investment in the Telecommunications and Information Technologies sector, which reports directly to the Minister's Office, coordinated by Pedro Mendes de Carvalho.

Summary: Approves the Regulation of the procedure to carry out private investment. Repeals Presidential Decree no. 84/12, of 14 May, and Presidential Decree no. 166/12, of 17 July.

# PRESIDENTIAL DECREE NO. 184/15 - PRESIDENT OF THE REPUBLIC

# DIÁRIO DA REPÚBLICA SERIES I NO. 134, OF 30 SEPTEMBER 2015

**Summary:** Extinguishes the National Agency for Private Investment (ANIP), creates the Angolan Agency for the Promotion of Investment and Exports (APIEX – Angola), transfers to APIEX-Angola the assets and liabilities of the extinguished ANIP and approves its organic statute. Repeals Presidential Decree no. 113/11, of 2 June, and Presidential Decree no. 189/13, of 18 November.

# PRESIDENTIAL DECREE NO. 170/15 - PRESIDENT OF THE REPUBLIC

# DIÁRIO DA REPÚBLICA SERIES I NO. 128, OF 15 SEPTEMBER 2015

**Summary:** Approves an additional credit in the amount of AKZ 490 million for the payment of expenses related to the operation of the Budgetary Unit of the Ministry of Finance.

# PRESIDENTIAL DECREE NO. 175/15 - PRESIDENT OF THE REPUBLIC

# DIÁRIO DA REPÚBLICA SERIES I NO. 129, OF 16 SEPTEMBER 2015

**Summary:** Approves the profile of those responsible for the General State Budget, namely of the Secretaries-Generals of the Ministerial Departments, the Secretaries of the Provincial Governments and the entities with equivalent assignments in the field of implementation of the budget of the Central and Local Administrative Bodies of the State.

# PRESIDENTIAL LEGISLATIVE DECREE NO. 5/15 – PRESIDENT OF THE REPUBLIC

# DIÁRIO DA REPÚBLICA SERIES I NO. 131, OF 21 SEPTEMBER 2015

**Summary:** Changes the rates provided for in the Consumption Tax Regulation and in the Customs Tariffs of Import and Export Duties. Repeals the items of Annex I, on the Schedule of Import Duties and of Consumption Tax applicable to Imports. It also repeals Annex II, on the Table of Consumption Tax relating to domestic production, which in the Customs Tariff of Import and Export Duties approved by Presidential Legislative Decree no. 10/13, of 22 November, with Rectification no. 1/14, of 30 January, and in the Regulation of Consumption Tax approved by Presidential Legislative Decree no. 3-A/14, of 21 October, coincide with the items set out in the annexes is provided for in this legislation.
